





Kampagne #IdentifyMe Unknown dead woman in Berlin city forest

Crime: Murder

Facts of the case:

Berlin public prosecutor's office and Berlin Land Criminal Police Office request your assistance! On 08/11/1988, at about 13:45 hrs, the partially skeletonised body of a woman was found in a pit apparently opened by animals in the town forest 'Spandauer Stadtforst' It is obvious that the woman fell victim to a homicide offence. The body had been packed in a jute sack. Around her neck, two short ropes made of synthetic material, which are usually used in water sports, were knotted. One is the end of a simple yellow rope and another is made of high-end material which might have been used as a "reefing line". The victim was found to be in possession of a torn piece of paper with a stamp impression of the counselling service for sexually transmitted diseases at the health office of Schöneberg district.

The soft facial tissues were reconstructed on the skull.

Reward:

For any information leading to the identification of the victim and solving of the crime, Berlin public prosecutor's office offers a reward of EUR 2,500.

Only private individuals are entitled to the reward. Officers whose professional duties involve the investigation and prosecution of criminal acts are not entitled to it. The reward will be granted and distributed without recourse to legal action.


Clothing:

- brown-beige coloured men's jacket with stand-up collar, front part made of linen, back part and sleeves made of knitted fabric, with Velcro fasteners
- grey thicker T shirt, smooth on the outside, brushed on the inside and/or thick men's vest
- blue jeans, US size 28
- pink thong (see picture)
- leaf-shaped earring with shining purple-turquoise metal (titanium) coating, approx. 3.5 cm long and 1 cm wide right ear (see picture)
- grid-type, rectangular earring with dark blue metal (titanium) coating, approx 4 5 cm long and 1 5 cm wide - right ear (see picture)
- silver-coloured digital ladies' wristwatch "MELODY QUARTZ ALARM-CHRONOGRAPH" of the
 company Juta with silver-coloured metal bracelet, square-shaped case, dimensions 3 x 2.5 cm
 (HxW), two pushers each on the sides, week days shown as letters S M T W T F S integrated in the
 rectangular glass with black and blue frame, on the back side presumably date "22 9 82" engraved
 under the signature JUTA (see picture)
- black-brown leather choker with clasp on her neck
- two terry cloth ties, red and black (hair ties) around right wrist
