





Kampagne #IdentifyMe Unknown dead woman in a marina in Bremen

CRIME: HOMICIDE

FACTS OF THE CASE:

Bremen public prosecutor's office and Bremen Land Criminal Police Office request your assistance!

On 30/07/2002, a body wrapped in a rug and other materials washed up at the sailing club Segelverein Weser e V in Bremen The autopsy revealed that it was a young woman whose dead body had floated in the water for about 4 weeks. So far, it has not been clarified whether the body was dumped in the river Weser near Bremen's football stadium 'Weserstadion' and objects of some weight were placed on the body or whether the body possibly floated through the river Weser from Lower Saxony up to the sailing club.

The identity of the young woman as well as the background to the crime have not been clarified to date. Before the body of the woman was dumped in the river Weser, her body had been bound with adhesive tape and then wrapped in a jute sack, plastic tarpaulin as well as in a rug and tied with cords.

There are indications of violence having been used against the woman's neck. The victim's death might have been caused either by this violence or the subsequent drowning. In this matter, investigations are being conducted into homicide. Reconstruction of soft facial tissues based on the young woman's skull in 2002 shows how the woman might have looked at the time of her death

REWARD:

For any information leading to the identification of the victim, Bremen public prosecutor's office offers a reward of EUR 5,000 EUR.

Only private individuals are entitled to the reward Officers whose professional duties involve the investigation and prosecution of criminal acts are not entitled to it. The reward will be granted and distributed without recourse to legal action.







PERSONAL DETAILS:

Age: 22 35 years (born between 1966 and 1980)

Height: 167 cm

APPEARANCE:

- delicate to child like build
- weight: approx 50 55 kg
- about 43 cm long dark blonde wavy hair, dyed golden blond, possibly permanent wave
- no tattoos, no conspicuous scars
- longer, manicured fingernails, purple nail polish with a layer of gold nail polish underneath,
 toenails with purple nail polish
- full set of teeth temporary fillings of two teeth recognised, consequently subsequent dental treatment must have been planned
- gave birth to at least one child in a natural way (child's year of birth between 1985-1999)
- well-groomed appearance
- right earlobe: silver-coloured earring with a red stone
- left earlobe: gold coloured ear stud with a dark stone
- neon green plastic hair clip in the shape of a butterfly

Packing material the dead body was wrapped in:

- a polyamide rug, dimensions 2m x 3m
- linen cloth with flower pattern
- plastic tarpaulin/sheet


CLOTHING:
